WAIVER OF LIABILITY AND RELEASE OF CLAIMS BY SIGNING THIS YOU GIVE UP ALL RIGHTS TO SUE

To: the Peterborough Paddling Club

And to: Her Majesty the Queen of Canada and Province of Ontario:

Canoeing and kayaking include lake water practice, river practice, white water maneuvering and rapid running, and volunteer and client activities associated with trips, courses, events, training sessions and facility maintenance and the travel and training involved.

I understand that canoeing and kayaking on lakes, reservoirs, and rivers involves certain dangers, not all of which can be listed here. Among the most obvious and frequent are:

- Exposure to variable extremes in weather that may cause injury due to heat and cold, and which may prevent or force route and itinerary changes.
- Contact with and possible immersion in cold water for undetermined periods; leading to hypothermia and possible suffocation.
- Exposure to capsizes, rocks, bridge abutments, log jams, rope entanglement, current patterns, and other possible sources of "in water" injury and entrapment.
- Unfamiliar terrain and routes, where canoeists and/or kayakers could become separated from the party.
- Transport by public or private motor vehicle.
- Travel in remote locations with poor communications and inability to get rescue or medical assistance easily or quickly.

I am not relying on any oral or written statements made by the Peterborough Paddling Club or its agents, whether in brochure, advertisements or in individual conversations to lead me to become involved in this activity on any basis other than my assumption of the risks involved.

I accept all of the risks and the possibility of death, personal injury, property damage and loss resulting from my involvement with any activity through the Peterborough Paddling Club

I release the Peterborough Paddling Club, its officers, employees, guides, agents and representatives from any and all liability for any personal injury, death, property damage or loss I may suffer as a result of my participation in any activity, for any cause whatsoever on the part of the Peterborough Paddling Club, its officers, employees, guides, agents, representatives or volunteers.

I certify that I am physically capable and fit to participate in the activity and I have no medical condition or needs other than those reported to the Peterborough Paddling Club, its officers, employees, guides, agents, representatives or volunteers.

I confirm that I have asked all my questions regarding the risks and am aware that the Peterborough Paddling Club was available to answer these questions.

I agree that the laws of the Province of Ontario govern this contract. I agree that any and all court proceedings will be conducted in the judicial area of Peterborough City and County.

I confirm that I have read over this agreement before signing, that I understand it, and that it will be binding, not only on me, but also on my heirs, next of kin, my executors, administrators and assigns.
